1	The total number of sections of Bal Vatika shall be restricted to 03 (01 section each for Bal Vatika 1, 2 and 3 respectively). The total number of sections from classes I to X shall be restricted to 15. Further increase of sections shall

	be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq. ft. dimension. The number of students in each class shall be restricted to 40.
2	Composite science lab does not have adequate seating arrangement for accommodating 40 students at a time. School shall upgrade the Composite science lab as per SOP of the board within 03 months and submit compliance with videography.
3	Mathematics lab appears to be temporarily established. Instead of proper demonstration tables, as per SOP, school has arranged few normal tables in the lab. School has made provision of plastic lounge chairs in the lab, which is not appropriate furniture for labs. The Maths lab needs to have more kits, teaching aids, students activity material and manipulative along with proper storage facility. School is directed upgrade the lab as per Board's SOPs and submit compliance
4	The school does not seem to have referred to RPwD Act and guidelines of the Board for CwSN toilets. The building is G+3, but only 1 CwSN toilet for girls and 2 CwSN toilets for boys are seen in the review inspection video. The School shall construct CWSN toilets separately for boys and girls on every floor with proper permanent signage, indicating the floor number and with all infrastructural facilities, as per norms of RPwD Act and guidelines of the Board within 03 months and submit the compliance with videography.
5	The school shall ensure the training of its teachers with CoE Vijayawada within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

- 1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.

- 4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school is required to renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

"The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms".

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
